Meeting Minutes: Minutes were reviewed and motioned for approval, for the April meeting, by Alondra Woodall and seconded by Cinnemon Weinhauer. All in favor.

Treasurer's Report: April and May Financials were reviewed. "Financials" submitted to the sponsor, District School Board of Pasco County via the Charters. Old Business: Ms. Cuffe shared an update for the Temporary Certificate of Occupancy (TCO)/Certificate of Occupancy Status which requires the final aspect of the project, the landscape design plan, to be fully and completely implemented (irrigation, plants, mulch, sod, etc) which the school, in collaboration with the selected vendor, anticipates to be completed around September 2023.
